Church Membership Policy

I. Statement of Purpose

The difference between being a Christian and belong to a church family (membership) is the understanding of "commitment." A Christian is by committing his/her life to Christ. Members of a local church are by committing themselves to the other Christians and the manifestation of the universal church.

At LIALC we would not ask our active members to do more than the Bible clearly stated. We only expect our members to do what the Bible expects every Christian to do (LIALC – membership covenant.)

Local Church & church ordinance

"And they were continually devoting themselves to the apostles' teaching and to fellowship, to the breaking of bread and to prayer." (Acts 2:42 NAS)

"For even as the body is one and yet has many members, and all the members of the body, though they are many, are one body, so also is Christ. ."(1 Corinthians 12:12 NAS)

Worship

" If you turn away your foot from the Sabbath, From doing your pleasure on My holy day, And call the Sabbath a delight, The holy day of the LORD honorable, And shall honor Him, not doing your own ways, Nor finding your own pleasure, Nor speaking your own words..." (Isaiah 58:13 NKJ)

Fellowship

"Let us not give up meeting together, as some are in the habit of doing, but let us encourage one another-- and all the more as you see the Day approaching." (Hebrews 10:25 NIV)

Service

"4 Now there are varieties of gifts, but the same Spirit...7 But to each one is given the manifestation of the Spirit for the common good...11 But one and the same Spirit works all these things, distributing to each one individually just as He wills. 12 For even as the body is one and yet has many members, and all the members of the body, though they are many, are one body, so also is Christ. "(1 Corinthians 12 NAS)

Giving

"And the congregation of those who believed were of one heart and soul; and not one of them claimed that anything belonging to him was his own; but all things were common property to them. "(Acts 4:32 NAS)

- Practical reason- it defines who can be counted on. Membership identifies who is in our family and who is not part of the local church. It helps the LIALC church to be accountable as body of Christ (Eph. 4:1-6, 12; Heb. 10:25; Mat. 18:15-17)
- Personal reason as Christians, we are accountable to each for spiritual growth. You can not be accountable when you are not committed to any specific church family.

Therefore, LIALC will recognize the need for a formal membership in our local church. By fulfilling the biblical responsibilities of the local church, the local church will manifest their gifts and the universal church what God intended. (1 Cor. 12:27-28a; Eph. 4:11-13)

II. Becoming a LIALC member

- Profess faith in Jesus Christ as Lord and Savior
- When you baptize into the LIALC or transfer membership
- All LIALC baptize members will only receive a church baptism certificate (no church letter.)
- At the age of 18.

Transfer membership

- You will need to meet the standing of the active membership
- A notice send to your previous church that you had become a transfer member to LIALC.

Active membership

- Completed the membership class
- Observe the teaching of this membership policy
- Receive the right of the LIALC constitutional privileges
- Constitute the voting body of the church
- Regularly attending LIALC worship service and/or Fellowship is necessary.
 Although your presence at the fellowship gathering is needed, observing Sabbath Sunday worship should not be overlook.
- Observing of church special meeting. (Baptismal service, Good Friday Service, pastoral issues, financial...etc.)
- *Must attend annual meeting, cannot miss two consecutive years.*
- After 2 years in a row using Absentee ballot, member will need a written request for the absentee ballot.

Inactive membership

- Away from the local church due to schooling or outreach ministry w-permission.
- Did not fulfill your active-membership obligation within 3 months. You will forfeit the church constitutional privileges of an active member.
- *Missing Annual meetings, 2 years in a row.*

Dismissal -membership

- LIALC does not hold dual local church memberships. LIALC encourage you to serve and belong to a local church so you can witness to the kingdom. Please inform us when you had transferred your membership.
- *Terminated by death*
- Leading a life dishonoring to Christ and His church
- Fail to comply <u>church discipline policy</u>

III. The course of action of the membership status changed from active membership

- The church purpose is to restore inactive member to an active member.
- The church will issue a letter or a visitation of following up concern about the spiritual health of the individual and his/her absence.
- Finally, another letter will issue to them and inform the status of membership changed
- No membership status change during the month of September or during the two weeks prior of a special meeting.

IV. Petition of your membership status – to reactivate your membership

Let us know (office) of your return, that you are willing to recommit your biblical responsibility to LIALC. After satisfying your active membership requirement for 3 months, the church would re-establish your membership with a notice.

V. Church Membership List:

- The Board of Deacons is required to review and updated membership listing at minimum three times a year. There will be no revise membership status during the month of September.
- The maintenance of membership records will be part of the stewardship department.
